### **REPORT IN TERMS OF SECTION 132(3)(a) and (b) OF THE COMPANIES ACT 71 OF 2008 (AS AMENDED) ("the Act")**

#### **FONTAINEBLEAU WINE EMPORIUM (PTY) LTD (IN BUSINESS RESCUE) (REGISTRATION NUMBER 2020/125662/07) ("the Company")**

Dear Sir/Madam,

1. The proposed business rescue plan was adopted by creditors on 29 June 2021.
2. The BRP's have since that date proceeded to implement the business rescue plan which includes, inter alia, implementing the sale of business and assets, collecting the book debts of the Company and paying creditors.
  - 2.1. During the month of December 2021 an application was made to sequestrate the estate of the sole shareholder.
  - 2.2. Fontainebleau Wine Emporium is one of the applicants.
  - 2.3. The application was successful. The Master of the High Court has appointed a provisional trustee to administer the sequestration.
  - 2.4. Fontainebleau Wine Emporium has lodged a claim against the estate.
  - 2.5. An application by a third party has been made for leave to intervene in the application for sequestration of the shareholder. A date in mid-September 2022 has been set down to hear arguments.
3. Creditor Claims and Distributions to Creditors
  - 3.1. Creditors are required to submit claims in respect of all amounts due to them. Once received the claims will be reconciled to the companies records and thereafter adjudicated by the business rescue practitioner.

- 3.2. Creditors whose claims have been reconciled, adjudicated and accepted have received formal notice of acceptance of their claim.
- 3.3. To date 92% of creditors have submitted the required formal claim as detailed in the Business Rescue Plan of which 88% have been accepted/finalised.
- 3.4. Creditors are encouraged to submit claims using the brpa.co.za tool. The deadline for submitting claims, as detailed in the Business Rescue Plan, was 30 September 2021.
- 3.5. To date 8% of creditors have not submitted a claim.
- 3.6. Distributions will only be paid to creditors whose claims have been submitted, reconciled, adjudicated and accepted.
- 3.7. Distributions will be paid to creditors in accordance with the provisions of the Business Rescue Plan.
- 3.8. A first distribution of 2 cents in the rand on their respective claims has been paid in February 2022 to creditors whose claims have been submitted, adjudicated and accepted.
