Activities that took place in March 2026

1. The BRP's continue to engage with the trustees of the estate of the sole shareholder to monitor progress with regards to realisation of assets and distribution to creditors
2. Financial Statements have been completed to date
3. Income Tax returns have been completed and submitted

General Business Rescue Information

1. The proposed business rescue plan was adopted by creditors on 28 June 2021.
2. The BRP's have since that date proceeded to implement the business rescue plan which includes, inter alia, implementing the sale of business and assets, collecting the book debts of the Company and paying creditors.
3. The estate of the sole shareholder has been placed into final sequestration in the hands of the Master of the High Court. The Company's claim has been submitted and proven. Good progress is being made on the realisation of the shareholders assets.
4. Creditor Claims and Distributions to Creditors
 - 4.1. Creditors whose claims have been reconciled, adjudicated and accepted have received formal notice of acceptance of their claim.
